    - i. PGSG Treasurer
      - 1. 2 individuals reached out stating that they would be running for Treasurer. Only one was present.
      - 2. Senator from Educational Studies nominates Shuangtng Li for Treasurer
        - a. Candidate Speech
          - i. Student in Educational Psychology
          - ii. Looking forward to making impact to this community
          - iii. Currently participates in GRAC team as a grant reviewer
          - iv. Believes he can make more impact in PGSG with this position
          - v. Experience Pretty good at different statistical modeling and techniques
            - In his degree work, he learns different, higher levels of statistic skills that are perfect for the Treasurer position
            - 2. Can apply statistic skills to the position and make the statistics clear to all team members so that they understand
          - vi. Works with other team members in research groups and as TAs and understands the importance of communicating with each other, especially with other team members.
          - vii. Serving as a grant reviewer for GRAC, he learned how students need this financial support from PGSG.
          - viii. Feels like he wants to make more of an impact to help Grad students get financial help from the team
          - ix. Goal in this position is to work with team members and create a better environment for students who need this financial aid.

- i. We've had challenges with the PRO last semester. As the vice PRO, how much power or decision making were you involved in and how do you plan to avoid these challenges.
  - 1. I do not know the exact challenges that you had with PRO. I stepped in as Vice PR to handle Social Media
  - 2. Had 60% increase in student communications
  - 3. Makes sure the newsletter is disseminated promptly at the same time each week.
  - 4. In my power, I did everything I was supposed to do.
- ii. You mention you have a lot of skills and sound impressive. It seemed that everything was on the PRO officer last semester. What is your plan for working with people, building a team, treating people, etc.
  - 1. Having more people on board is a good idea.
  - 2. Everything needs to be delegated.
  - 3. As Vice PR, made sure I handled everything that I was in charge of
  - 4. Working as a team/having team spirit will help with this

- iv. Previous PRO began an overhaul of the PGSG website, which was not completed. Do you have the skills/plans to complete or revise the website further?
  - 1. I can very much assure that I can handle that.
  - 2. I learned that he moved the website from Bluehost to Wordpress which is more user friendly.

    - 2. Author There are some things that need to be changed with the constitution, specifically the wording. This legislation changes some wording around. LRC says it is good.

  - 3. President Great Legislation
  - 4. Parliamentarian This allows committee chairs to be senators, which we currently do but is not technically allowed (it's a gray area)

    - a. Seconded by the Senator from Math
    - b. Reading waived by general consent
  - Author Senator from CS Senate chair does not have much say in the
    establishment of Senate meeting days. They should have the ability to help
    choose which days Senate meetings are held on.
  - 3. President great legislation
  - 4. Parliamentarian this is constitutional
  - 5. Period of questions
    - a. Motion to table made by the Senator from HDFS
      - i. Seconded by the Senator from Math
      - ii. 50% majority required
      - iii. Ayes have it, tabled until next meeting
- iv. SP24-R001 "Resolution on Boycott, Divestment, and Sanctions at Purdue University"
  - 1. Point of Personal Privilege Parliamentarian will we be using discord for this discussion?
    - a. Chair We will indeed
  - 2. Motion to waive reading made by the Senator from Math
    - Seconded by the Senator from HDFS
    - b. Nays have it, Senate Chair Reads legislation.
  - 3. No motions to read exhibits were made, so exhibits were not read.
  - 4. Senator from Math Yields time to the Authors–
    - a. Situation that has been under-addressed by the university
      - i. inspired by the Boycott, Divestment, and Sanction movement
      - ii. This movement is a global movement.
      - iii. Prescribes action.
    - b. Over 25K palestinians killed, over 60K starving
    - c. This conflict is nothing less than genocide
    - d. Nothing justifies our silence





- e. We are killed twice, once by the bombs, once by the silence
- f. It is our moral obligation to analyze purdue's role in this conflict
- g. Their goal is to erase the Gaza strip
- h. We need to speak to Purdue's ties to the military industrial complex.
- i. Take action for human interest over war.
- 5. President The right to free speech is something that Purdue values
  - a. More interestingly, hate speech falls under this right.
  - b. I want to get at the fact that, irrespective of the opinions of constituents, cementing yourself in a position that supports only one side puts you in a backroad.
  - c. Being neutral allows us to support our students. You are here advocating for all parts of your constituents
  - d. Certain clauses call for Purdue to end contracts. Based on convos with others, this will not happen
  - e. this is an anti-Israel legislation
  - f. There is a clause that talks about 42 organizations on campus who support this legislation. Over a thousand organizations on campus
  - g. Just like Purdue values free speech, there will not be backlash on any of you for your opinions.
  - h. Remember the role you serve and the people you serve.
  - i. This can create a certain wave on our policies in the future.
- 6. Parliamentarian Yes this Legislation is constitutional.
  - a. Difficult to not be constitutional. Resolutions make requests, but do not necessarily make the changes. Everything requested here is in our power to request.
- 7. Chair Public members, Thank you for attending
  - a. Want to know that only Senators have speaking privileges (aside from the authors, the PSG representative, and our PGSG sponsor) unless they yield their time
  - b. Discord will be used to submit names to the speaking order. Authors, since you are not in discord, raise your hand and I will make a note for the speaking order.
- 8. Period of questions for factual clarification.
  - a. Parliamentarian Noted that this has been supported by a number of student organizations and that this has been passed to the University Senate, is this correct?
    - i. Authors We have given this to the Board of Trustees (BOT), as a piece of paper, but not in an official capacity
    - ii. President Board of Trustees only hears formally presented pieces. While this has been delivered, it will not be considered until presented by specific individuals
  - b. Senator from Senator from PULSE You named a bunch of companies you want Purdue to end ties with. What resolution will allow Purdue to keep these ties?
    - i. Authors these companies are part of the military industrial complex. As long as there is constant war and these weapons



are being used to kill innocent Palestinians, there is nothing else that can be done.

- 1. This legislation's aim is to assess Purdue's own actions in this conflict. While we don't have hopes to end hostilities, we hope to act in more modern ways
- 2. If any companies stop their relationships with Israel, they can continue working with Purdue
- c. Senator from BPP a numberA n of organizations organizationshave signed this. How did you manage to get these signatures. Is this house going to pass this based on 42 organizations? Were you able to reach out to more organizations?
  - i. Senator from Senator from Math PGSG regularly passes legislation from single organizations organizations.
  - ii. Authors the organizationsorganizations that signed this did so on a voluntary basis. Members from different organizationsorganizations volunteered to bring these forward to their organizations. Not saying that all organizationsorganizations agree with us, but that these organizationsorganizations chose to support this.
  - iii. These took an active role in this organization
  - iv. Demographics of these organizations they serve different demographics.
  - v. Organizations that have signed have big audiences.
- d. Senator from Senator from ATT Can you clarify what country these companies are based in and what their contributions are, as this is vague, and why these companies were chosen.
  - i. Authors A lot of the military contractors are American countries
  - ii. Other organizations are Israeli companies. There are different companies with different connections.
- e. Parliamentarian Motion to end questions and move to period of discussion.
  - i. Seconded by the Senator from Senator from HDFS
  - ii. Requires <sup>2</sup>/<sub>3</sub> vote to carry
  - iii. Motion carries, period of questions ends.
- 9. Period of Discussion
  - a. Discussion will go in an alternating fashion, starting in the opposition. As long as things are respectful, it will be in order (so inflammatory remarks can be made as long as they are they are made respectfully)
  - b. Senator from Senator from Biochem Thanking authors for writing legislation. Well-crafted.
    - i. I stand with the people of Palestine and I apologize for my
    - ii. Despite my personal affiliations, I am a senator. A lot of my constituents are on different sides of this.



- iii. If we condemn a nation such as this, and god forbid that any students get hurt because of this, I will not be able to sleep at night.
- iv. I will not support this.
- c. Senator from Senator from Mathematics Want to talk about the difference between possibility of people feeling unsafe, which is unfounded, however I think there is discomfort no matter how we vote on this
  - i. The possibility of unsafeness here, we have to weigh against the genocide happening in Gaza.
  - ii. Yield to Authorss Regarding hate speech as Free Speech
    - Remaining neutral could be applied to other documents passed previously, including when PGSG supported Lesbian, Gay, Bisexual, Transgender, etc. (LGBT+) students, Black Lives Matter (BLM), etc. We should not let the idea of neutrality hinder us
    - 2. Students have been removed from Purdue for hate speech
- d. Senator from Senator from BPP Great resolution, I understand the importance of it
  - Want to mention, Purdue is an independent institution that houses everybody, including the two parties involved in this conflict
    - 1. I want to say that there are different conflicts going on and that there is too much suffering.
    - 2. We need to figure out how to ameliorate this situation without conmening one side
- e. Will not support this resolutionSenator from Senator from HDFS On the issue of neutrality
  - i. Neutrality is subjective who are we neutral for?
  - ii. Purdue has already taken a side.
  - iii. By being a labor force for Purdue, Grad students work for these groups.
  - iv. Yield to Authors What is going on right now in Gaza is Apartheid.
    - 1. South Africa has a case against colonizers
    - 2. We do not use genocide lightly
    - We cannot claim neutrality when the university works with organizations that support Israel in this situation
    - 4. Purdue's President goes to secret Hillel meetings, but does not meet with palestinian groups on campus
- f. President Hate speech being free speech is something that Purdue Legal endorses until the speech endangers or threatens anyone involved (this is supported by Provost)
  - i. PGSG and PGSS can support/pass any cause based on the voices of your constituents



- ii. PGSG is also a student fees funded organization which means that every grad student contributes to this body
- iii. You being here, us renting this room, us giving any financial contributions, we make ourselves liable to our student bodies.
- iv. We have taken sides in legislation before, but the aftermath is often not reported.
- v. You should be able to voice and do what you will as the students of this organization
- vi. None of us are equipped or educated enough
- g. Senator from MSE Seeing the specific organizations who supported this legislation should remind us that this will allow us to support a lot of groups. We need to stand in solidarity with these groups.
  - i. This is our platform to share our support for these groups.
  - ii. There is evidence of Anti-palestinian issues, and the university's support for Israel
  - iii. Example of what happened at Columbia University
- h. Senator from ATT I want to express my appreciation for the effort put into this legislation. It is a good read.
  - i. It is not in my constituents' interest to pass this. A lot of these companies work with my constituents
  - ii. These companies' produce weapons that reduce casualties (precision)
  - iii. I don't think that this is something that we should disconnect ourselves from
  - iv. Politically there are issues to be addressed, but working with the military, it is our job to do these things.
  - v. I think it may be useful for Purdue and your cause to express your opinions to your state's senators/representatives.
  - vi. As representatives of the student body, we should not take a stand on this or support this one side.
  - vii. It is okay to have personal opinions, but it is not something the entire body shares.
- i. Senator from Mathematics
  - i. Point of Order Parliamentarian No speaker can speak twice in a particular discussion period unless/until all speakers on the list have spoken at least once.
- j. Authors Want to start off by clarifying that we have had time to make sure antisemitism does not seep into what we are doing here
  - i. There are multiple Jewish organizations that have supported
  - ii. We try to keep Jewish voices/perspectives in loop.
  - iii. It is not that we don't want to hear the other side.
  - iv. Did the student governments' take the beliefs of racists/homophobes when supporting BLM and LGBTQ communities?
    - 1. Did they take into account pro-lifers?
    - 2. The answer is No and rightly so.





- 3. All opinions should be considered and valued, except when they support systems of apartheid/genocide.
- k. Senator from ECE I hate the war going on between Israel and Palestine
  - i. I would support a resolution that finds a way to end the war.
  - ii. Someone's motivation will be correct, but their approach may not be.
  - iii. I looked at the citations stated —
  - iv. Senate Chair Time of adjournment has been reached
    - 1. Motion to extend the meeting until 8:30 made by the Parliamentarian

# Purdue Graduate School Transformation Final Report and Recommendations Eric Barker, Associate Provost for Graduate Programs (Acting) January 3, 2024

**Background**: In June 2023, President Chiang and Provost Wolfe requested that Dr. Barker conduct a thorough and thoughtful review of current functions of the Purdue Graduate School with an emphasis on identifying mechanisms to enhance graduate and professional student support and career preparation while removing administrative barriers to student success.

A deep-dive of all Graduate School functions was conducted over the fall 2023 semester. Key stakeholders were also engaged in this review, including the academic deans, the college-level associate deans for graduate education, the associate deans in the Graduate School, the Purdue Graduate Council, and University Senate leadership. The focus of these stakeholder conversations was asking fundamental function and structure questions such as: Is the term "Graduate School" necessary and relevant to the scope of activities currently housed in Purdue's Graduate School? Are there other options? If there is to be a new structure, it cannot devalue graduate education and should impress the importance of graduate students, professional students, and post-doctoral fellows at Purdue.

Overall, the intent is to better support graduate and professional programs at department, college, and university levels with the following overarching principles:

- The North Star is student success. As feasible, more resources should be devoted to students directly and processes streamlined for the ease of student life as graduate programs at Purdue grow.
- All essential functions at the university central level will continue, including hosting certain interdisciplinary graduate degree programs.
- Since graduate admissions have always been run mostly at department/program and college levels, faculty in individual graduate degree programs will be further empowered to innovate in graduate education.

**Benchmarking:** A key question was, *how do the Top Five Public Universities handle graduate programs?* The following structures exist:

- UC-Berkeley Berkeley Graduate Division led by Vice Provost and Dean
- UCLA Division of Graduate Education led by Dean, Division of Graduate Education
- University of Michigan Ann Arbor Rackham Graduate School (or School of Graduate Studies) led by Dean and Vice Provost for Academic Affairs – Graduate Studies
- University of Virginia Office of Graduate & Postdoctoral Affairs led by Associate Vice Provost and Director
- University of Florida The Graduate School led by Associate Provost and Dean

Of note, three of the top five public universities have a support structure distinct from a traditional "Graduate School."

#### **Recommendations:**

- 1. To better align with the overall functions, rename the Purdue Graduate School to the Office for Graduate Students and Post-Doctoral Scholars to be housed in the Office of the Provost.
- 2. The Office for Graduate Students and Post-Doctoral Scholars would be led by the Vice Provost for Graduate Students and Post-Doctoral Scholars.
- 3. The Vice Provost will be supported by Associate Vice Provosts and Directors as deemed necessary to support core functions.
- 4. The following specialized and centralized services for graduate students and post-doctoral scholars will continue:
  - Interdisciplinary Graduate Programs
  - Program and curricular approvals
  - "GRAD" courses
  - Graduate records database
  - Fellowship management
  - Post-doctoral fellow support
  - Admissions management
  - Professional development
  - Graduate assistance and advocacy
  - Graduate student success programs
- 5. All graduate and professional degrees will be awarded by the home College. Admissions decisions and offers will continue to be managed by the home College with continued support from the Office for Graduate Students and Post-Doctoral Scholars. Interdisciplinary program students will "officially transfer" into their home College/Department (program) in their final semester so that their degree will be awarded by the home College.
- 6. The Graduate Council charter and charge from 1949 should be reviewed in Spring 2024. The membership and purpose for the Graduate Council should be updated. A joint Task Force between the Graduate Council and University Senate should be charged with this review with a target of having any changes approved by both Graduate Council and University Senate by May 2024.



# Senate Document 23-16 20 November 2023 (revised)

**Rationale:** The November 7, 2023 press release announcing the appointment of

David Malpass as the Distinguished Fellow of International Finance

at the Mitchell E. Daniels, Jr. School of Business and as the Inaugural Fellow of Global Business and Infrastructure at

Purdue@DC described him as a "leading economist on Wall Street."

and provided an uninformative recitation of his actual responsibilities.[1] The announcement presented a highly

incomplete version of his career.

Mr. Malpass has a history of poor fiscal judgement. Mr. Malpass worked at Bear Stearns for 6 years, and was its chief economist—having misread the effects of the housing/credit market—when Bear Stearns went bankrupt in the 2008 financial crisis.[2] In addition to his work at Bear Stearns, Mr. Malpass was Senior Economic Adviser to Donald Trump during his Presidential campaign, authoring the article, "Why This Economy Needs Trump," which advocated for the federal-debt-exploding Trump-era tax cuts.[3]

Mr. Malpass is not representative of Purdue values. As Republican candidate for United States Senator, he, when questioned, <u>was</u> against gays serving openly in the United States military.[4]

Mr. Malpass has demonstrated questionable business ethics. He has been creditably accused of having a family member benefit from nepotism. World Bank staff were apparently told to give preferential treatment to Robert Malpass, son of David Malpass, when the latter was serving in the Trump Treasury Department. They were encouraged by a senior manager to curry favor with Robert Malpass; the staff referred to 22-year-old Robert Malpass as a "prince" and "important little fellow," who could go "running to daddy" if things went wrong. Robert had joined the World Bank's IFC division in July 2018 as a research analyst. The then 22-year-old had just completed his bachelor's degree in economics.[5] We do not want the graduates of the Daniels School of Business to think that such behavior is acceptable for a Purdue graduate.

Similarly, Mr. Malpass has failed to take seriously a corporate culture of sexual harassment where he was in charge. In a <u>recent</u> <u>report</u>, it was revealed that when David Malpass was the President of the World Bank, there was a coverup of a sexual abuse scandal at an institution funded by the World Bank and retaliation against a World Bank whistleblower.[6] Members of Congress are now investigating this case. There was also an earlier <u>sexual-harassment</u> <u>coverup scandal</u> at the World Bank that spanned the Presidency of Malpass, in addition to that of earlier World Bank Presidents.[7]

In addition, Mr. Malpass doubts the science of climate change. The revelation that Mr. Malpass was as a climate-change denier led to his premature resignation from the Presidency of the World Bank. When asked directly, "Do you accept the scientific consensus that the man-made burning of fossil fuels is rapidly and dangerously warming the planet?" he responded, "I don't even know—I'm not a scientist." He later retreated from this position.[8] However, this was not the first time that Malpass had hedged on climate change and will be unlikely to be the last.[9]

Given such a record, it is unclear why Purdue University wanted to give such a prestigious position to a person with such a questionable portfolio.

**Rationale:** Purdue University Senate is governed by the first edition (2012) of

The American Institute of Parliamentarians Standard Code of Parliamentary Procedure. However, in 2023, the AIPSC was issued

in an improved and expanded second edition.

Secretary and Parliamentarian Powell convened a working group to make a recommendation regarding the adoption of the new edition. After careful study, it is the opinion of the group that the new edition makes several changes that may be useful to our body (see appendix below), and that the Senate should adopt it as our new

standard.

**Proposal:** Bylaw Article VII will be modified as follows:

7.00 Authority on Parliamentary Procedure  The first edition (2012) of The American Institute of Parliamentarians Standard Code of Parliamentary Procedure governs this Senate in all parliamentary situations that are not provided for in the University Code or in these Bylaws.	7.00 Authority on Parliamentary Procedure  The current edition of The American Institute of Parliamentarians Standard Code of Parliamentary Procedure governs this Senate in all parliamentary situations that are not provided for in the University Code or in these Bylaws.

# Excerpt from the Introduction to AIPSC 2<sup>nd</sup> edition:

# Changes related to governance and fundamentals:

- changing the default provision to amend bylaws changed from previous notice and majority vote to previous notice and a two-thirds vote
- removing member discipline information from "Rights and Responsibilities of Members and of Organizations" to form a new chapter
- establishing a process for handling individual bylaw amendments to existing bylaws should a revision fail
- providing sample emergency bylaws

#### Changes related to motions:

- replacing the concept of restricted debate with a requirement that debate be germane to the motion at hand;
- making Close Debate and Vote Immediately amendable as to the motions to which it applies;
- removing the debatability of motions that limit debate;
- removing the concept of a substitute amendment because a substitute was already treated as an amendment to strike out and insert; and
- establishing that after debate has been closed, Factual Inquiries are not permitted, although a Parliamentary Inquiry may be.

# Changes related to meetings:

- clarifying the methodology and motions used to create a continued meeting;
- clarifying rules related to the formation of a convention or house of delegates, particularly those related to credentials;
- providing sample rules for a hybrid meeting;
- establishing electronic notice as a default permission, unless prohibited by statute or the bylaws;
- establishing that electronic meetings are allowed, unless prohibited by statute or the bylaws; and
- providing that a change from in-person to virtual, or vice-versa, does not invalidate a notice, provided all members are notified.

Finally, great effort was made to adjust nomenclature to the common meaning of the words and eliminate the overuse of the word special.

- Specific Main Motions were changed to Specific-Purpose Main Motions.
- Special Orders were renamed Scheduled Orders.
- Standing and Special Rules of Order were changed to Standing Rules of Order and Temporary Rules to describe their purposes more accurately.
