- I. SP24-R001 "*Resolution on Boycott, Divestment, and Sanctions at Purdue University* a. Period of Discussion
  - i. Point of privilege Parliamentarian Motion to allow the legislation's coauthors to reenter the session
    - 1. Seconded by the Senator from Math
    - 2. Requires a simple majority
    - 3. Motion carries with no objection
  - **ii.** Senate Chair to the authors Because this is an executive session, what is said and what happens in here is not allowed to be released to the public unless the Senate elects to do so at a later time.
  - iii. Point of Privilege by Senator from Chemical Engineering On behalf of the senator from AAE who appeared to unmute, but did not.
  - iv. Senate Chair to the Parliamentarian does the speaking order reset?
    - 1. Parliamentarian if nobody in the Speaker order was expelled, then no it does not reset.
  - v. Senator from Math Would like to say how disappointed they are and how undemocratic it was to go into executive session
    - 1. There were constituents who wanted to hear what we have to say and what decision we make
    - Boycott, Divest, and Sanctions (BDS) movements happen all the time. It is very common for companies to sever ties with countries who do bad things
    - 3. Colleges around the country ended ties with Russia when they invaded Ukraine
    - 4. This past Monday, the University of Michigan Faculty Senate voted to divest
    - 5. This is huge. BDS movements have been happening for 20 years.
    - 6. It took 40 years in South Africa, but they did it and ended apartheid.
  - vi. Senate Chair Point of information to the meeting's cohosts nobody else can be admitted to this meeting now that we are in executive session.
  - vii. Senator from Chemical Engineering Would like to hear from other senators, but it seems that the ones speaking are all repeats
    - 1. In a complex situation as in Israel and Palestine, there are complex realities that are not the fault of Israel.
    - 2. Therefore, I oppose BDS-ing Israel
    - 3. I motion to end discussion and move to a period of voting on the legislation
    - 4. Requires a  $\frac{2}{3}$  majority not debatable
    - 5. Seconded by President
    - 6. Senate Chair can executive board members second these motions?
    - 7. Parliamentarian yes

- 8. Point of Information from the Senator from BPP I think you confused me with another senator, I have not spoken this time
  - a. Senate Chair that was about the speaking order from both the last meeting and this one and in the last meeting you did speak on this legislation.
  - b. Senator from BPP So we combined the speaking order from the last meeting and this meeting?
  - c. Senate Chair yes
- 9. Point of order this says FA23-B005 on virtual poll for voting
  - a. Senate Chair yes I forgot to change it, but it's meant to be a vote on this motion
- 10. Vote on the motion to end discussion and move to a period of voting:
  - a. Ayes: 29
  - b. Nays: 13
  - c. Ayes have it, Discussion is now closed.
- viii. Senator from Math Motion to make the vote public.
  - 1. Motion is in order
    - 2. Seconded by Senator from ATT
      - a. Requires a 50% majority to carry
    - 3. Point of inquiry by Senator from ATT is this debatable?
      - a. Parliamentarian do not think it would be since it is requesting a different form of voting
      - b. Senate Chair no this is just another motion
    - 4. Voting on motion
      - a. Ayes 14
      - b. Nays 29
      - c. Motion does not carry, votes will be anonymized.
- ix. Voting on SP24-R001
  - 1. Ayes: 11
  - 2. Nays: 21
  - 3. Abs: 5
  - 4. Legislation fails, SP24-R001 does not pass.
- x. Point of Order Senator from ECE My vote went away after I put it in?
  - 1. Senate Chair yes, because it is anonymous so it will disappear once it is counted. You should get a direct message from the bot telling you that your vote was counted
- **xi.** Point of inquiry Senator from Sociology Wondering if the vote disappeared from the list because it was anonymous, if they press it again will it log it twice?
  - 1. Senate Chair according to the bot it is supposed to override that
  - 2. Senator from Statistics If you hit it twice you remove your vote completely
- **xii.** Senator from Math Motion to revote on the grounds that there was confusion with the poll
  - 1. Parliamentarian you can move to do that. Oddly enough, I think there is a vote to revote, but it could be moved by unanimous consent
  - 2. Seconded by Senator from HDFS
  - 3. Point of Inquiry Senator from ECE is it possible to see a list of senators who voted without their votes?

- a. Senate Chair: It is not, I just get the number of votes and cannot see any names.
- 4. Any opposition?
  - a. Opposed by President
    - i. Point of order Parliamentarian President is not a voting member and cannot oppose
  - b. Point of Order Senator from VCS make it clear that if we click once we should not click again
    - i. Senate Chair we will come to this if we revote
  - c. Opposed by Senator from VCS
  - d. Requires a 50% majority
    - i. Ayes: 26
      - ii. Nays: 14
      - iii. Motion Carries, we will recount the anonymous poll.
- 5. Senate Chair Do we have a better suggestion to do this vote?
  - a. Parliamentarian Just note that if you click twice, it removes your vote.
  - b. Senate Chair You will receive a message from the bot that your vote was counted
  - Senate Clerk Also note that you have to wait a moment to receive that message, it does not necessarily come immediately
- 6. Vote recount
  - a. Ayes: 14
  - b. Nays: 22
  - c. Abstentions: 7
  - d. Legislation fails.
- 7. Point of information Senate Chair am I allowed to disclose the vote?
  - a. Parliamentarian to the public?
  - b. Senate Chair Pass it on because it is a joint resolution.
  - c. Parliamentarian on the Joint legislation side, you simply do not pass on anything since it is no longer a joint resolution
  - d. Senate Chair is there anything that allows us to allow the vote to be shared for the legislation
- 8. Point of Privilege Parliamentarian Motion to exit executive session and return to regular session
  - a. Seconded by Senator from HDFS
  - **b.** Ayes have it. The executive session has ended and PGSS returns to regular session.
