  - A more detailed description is in Appendix A., but it's not necessarily per diem, rather it could fund specific items
  - ii. Think about the PD grant, which is non-research, but this is more like research work. You can ask for specific things like pencils and pens too.

  - a. President You have to provide a letter from your advisor that your research isn't being funded by other sources. (so independent of other grant-funded research you have.

To my fellow graduate students and senators of the Purdue Graduate Student Senate,

Congratulations on your new/continuing positions! If you are continuing in your roles, I am happy to welcome you back to another term, and if it is your first term here, Welcome and I hope graduate student governance does not take up too much of your time. In your role as senator, you get to interact with your constituents and bring back their concerns to us, finally after deliberation, it is my role to bring forth graduate student concerns to the Purdue Administrative Body.

To effectively fulfill my role as President, I rely on the support of the PGSG Executive Board members who are entrusted with specific responsibilities. At this time, PGSG urgently needs a Parliamentarian and a Chief of Staff. During our August EBoard meeting, the PGSG Executive Board expressed unanimous confidence in working with Ali Holmes as Chief of Staff. As graduate students with demanding academic commitments, including our own dissertations, we currently do not have the capacity to train multiple individuals for the same role while also providing assistance to others.

The Executive Board (E-Board) of the Purdue Graduate Student Government (PGSG) recognizes the importance of effective communication and transparency. This year, as always, officer reports will be our primary means of sharing our actions, decisions, and responsibilities throughout the term. Our commitment is to ensure that every step we take reflects your best interests as graduate students.

We encourage an open environment where everyone can ask questions, seek clarification, and contribute to fostering collaboration and unity. An environment that is free of personal vendetta and focussed on the broader graduate student welfare. Together, we aim to build on the successes of the past year and create an even stronger, more vibrant graduate student community at Purdue University.

Thank you for accepting the responsibility to serve, and I look forward to working closely with each of you as we continue this exciting journey together.

Here is my report from 2023-24, which will be published as a part of the PGSG Annual Report from 2023-24:

As President of the Purdue Graduate Student Government (PGSG) for the 2023-2024 academic year, I am proud to present the accomplishments and initiatives that our team successfully executed during this period. This year has been marked by significant movement in securing funding, enhancing student support services, and fostering a more inclusive and engaged graduate student community at Purdue University.

# Securing and Allocating Grants for Graduate Student Support

One of the primary focuses of my presidency was to ensure that PGSG could effectively support graduate students through targeted financial assistance. Early in the year, I prioritized securing funding for critical programs, leading to the successful acquisition of \$25,000 for summer childcare grants. This funding, approved by former Dean Dr. Linda Mason, provided essential support for graduate students with families, enabling them to focus on their academic responsibilities without the burden of childcare expenses.



In addition to the childcare grants, I was instrumental in the establishment of two new grants: the Transitional Housing Grant and the Accessibility Grant. The Transitional Housing Grant, which received funding after extensive discussions with the Student Activities and Organizations (SAO) and Business Office for Student Organizations (BOSO), was designed to assist graduate students facing temporary housing challenges. This grant filled a significant gap in the existing support structure, ensuring that students experiencing transitions had the financial resources needed to secure stable housing.

The Accessibility Grant was another critical initiative introduced during my tenure. This grant aimed to support graduate students requiring accommodations to enhance their academic and campus experience. Although navigating the legal and administrative hurdles with SAO and BOSO required patience and persistence, the successful implementation of this grant underscored our commitment to inclusivity and equal opportunity for all graduate students. We are currently looking for a Vice Chair and are in the process of developing the forms.

### **Enhancing Campus Safety and Mobility**

Another achievement of my presidency was the enhancement of campus safety and mobility through the After Hours Shuttle Service. Recognizing the need for safe transportation options for graduate students, particularly those working late or residing off-campus, I secured \$40,000 in funding from the Associate Provost of Graduate Programs to maintain and expand this service. The shuttle program provided reliable transportation during late hours, significantly improving the safety and convenience for graduate students across the campus.

Furthermore, I initiated discussions with Procurement Services to explore partnerships with CityBus and other shuttle service providers. Our goal was to create a sustainable and efficient transportation network that would continue to serve graduate students' needs beyond the immediate academic year. Although some logistical challenges remain, the groundwork laid during this year positions PGSG to continue advocating for and improving graduate student mobility.

#### Addressing Budgetary Challenges and Financial Management

The financial health of PGSG was a significant concern as we entered the 2023-24 academic year, with the organization facing a substantial deficit. Our bank account was at an all-time low, with a negative balance of \$38,000. To address this, I worked closely with our Treasurer to reallocate funds and identify additional resources. We successfully transferred \$28,300 from the PGSG Surplus account to cover immediate operational needs and ensure the continuity of essential services and programs.

Despite these challenges, I was able to secure additional funding to support our initiatives. For example, additional funding to the effect of \$60k was brought into the PGSG to support our activities in 2023-24. I was able to allocate about \$10k in funding to MHAW in addition to their \$7k budget to make the events more successful.

#### Fostering Collaboration and Community Engagement

Collaboration was a key theme throughout my presidency, as I worked to strengthen relationships with various university stakeholders. I regularly met with the Acting Vice Provost of Graduate Programs, the Vice Provost for Student Life, Dean of Students, our Advisor (Associate Dean of Students), Board of



Trustees representative, PSG President and CAPS to align our initiatives with broader university goals and to ensure that the voices of graduate students were heard at the highest levels.

# **Governance and Legislative Advocacy**

As President, I took an active role in the legislative processes within PGSG. I worked closely with the Senate Chair to ensure that PGSG legislation was effectively communicated to the University Senate Steering Committee. This included advocating for the recognition of Juneteenth as an official university holiday, a significant step toward acknowledging and celebrating diversity on campus. Additionally, I supported the creation and implementation of new grants, including the Transitional Housing and Accessibility grants, which provided critical resources for students in need.

# **Conclusion and Looking Forward**

The 2023-2024 academic year was one of significant achievement and growth for PGSG. Despite financial challenges, we were able to secure critical funding, implement new support programs, and strengthen our advocacy efforts on behalf of the graduate student community. As I conclude my first term as President, I am confident that the initiatives and foundations we have established will continue to benefit Purdue graduate students for years to come. It has been an honor to serve as your President, and I look forward to seeing how PGSG will continue to evolve and advocate for the needs of our vibrant and diverse graduate student body.

### **Report from August Action Council**

PSG President and Hailey Oliver were absent. The Provost highlighted several key points: student trustees rotate every two years, and there's a need for collaboration with the Action Council on housing and wellness. Two new dorms have been approved, with \$600K invested in CAPS, including telemedicine. Graduate stipends and minimum wages for hourly student workers will increase, impacting dining and athletics. Housing priorities include managing applications (starting in October) and addressing the artificial demand for private apartments due to Purdue's freeze on tuition and room and board charges. Mental health, pedestrian safety, and feedback from Chris (Coach) are also important. Beth McCusky noted that 1900 new beds will open in the next two falls, with two new private apartment complexes added. The campus will not expand further, and the focus is on improving the experience for returning students and addressing off-campus housing issues, including parking and transportation. Provost Wolfe expressed interest in supporting the vacation pay for grad students and asked to schedule a meeting over coffee.

# **Report on After Hours Shuttle Service**

Successfully procured about \$40k for the year for the shuttle service that we pay Rides2U to run. Jia will be taking over as the coordinator of the service. This will begin on September 5, everyday between 6 pm - 1 am.

#### **Cultural Centers Graduate Senate Representation**

As the diversity officer, my primary goal is to ensure that all graduate students feel included, cared for and respected during their time at the university. To put what I do into context, I'm a harassment survivor due



to an unexpected power dynamic situation with an ex-academic advisor. Coming into Purdue, I didn't have the education and knowledge to realize that something was not right in my graduate school experiences. However, I am grateful to be supported by the deans of my college and the dean of the graduate school. Looking back, it was an unfortunate incident, yet, I felt fortunate at the same time to have received much support from this team at PGSG and my team of faculty advisors to be in such a position.

#### **Election of Vice Chair**

I received 4 nominations for the diversity vice chair and only one of those nominations submitted a statement, who is Laura. I eventually elected Laura to be the diversity vice chair and she received a 100% confidence vote from the team. Laura is excited to learn how PGSG works and will be there at the LGBTQ event and the RedZone Tailgate event. Laura has also been actively involved during the Express Fest, helping us with the networking with various entities at Purdue and during our new graduate student orientation.

#### **CARE Graduate Student Orientation and Senators Orientation**

On June 16, I met with the director of CARE, Tiffany to discuss the effort of Center for Advocacy, Response and Education (CARE) in what they can do for our graduate students. Tiffany expressed enthusiasm about collaborating with PGSG. She and her team have noted that with the power differential in graduate school, graduate students are often confused about what to expect and what are considered appropriate behaviors in graduate schools, especially when graduate students possess an inherent disadvantage under such power dynamics.

Somosmita, Victor and I chatted on the Teams meeting with Allison from the graduate school on the idea of CARE speaking during the graduate student orientation. Allison expressed excitement about the idea, and Tiffany from CARE has committed to speak this year and ten years forward during the graduate student orientation in view of how important having such knowledge is in graduate school.

Together with Victor, our senate chair, I worked with Tiffany to review her slides and provide her with suggestions on what to present to our new graduate students and senators.

## Senator Orientation and Express Fest with Cultural Centers is

Before the senator orientation, I engaged the advisors of various cultural centers via email to get graduate students who are interested in representing the cultural centers. I contacted Asian American, Latino, Native American, Black and LGBTQ centers to get them to join us. The graduate assistant of Asian American joined us on August 7, 2024, and we warmly welcomed him. LGBTQ appointed their graduate assistant, Theo Sorg, as our advisor for any diversity initiatives but did not have the capacity to represent the center at the moment. This is a similar situation with Black, Latino and Native American cultural centers. I do not view the lack of representation from these entities as concerning. Rather, relationship building is an ongoing and proactive process. We spread the word about such vacancies to these cultural centers and they will contact us if there is any graduate student who has the capacity to serve. The strategy Laura and I took during the Express Fest was to go to each table of the cultural centers with our PGSG swags to introduce ourselves and talk about involvement with PGSG. We networked and chit-chatted with CAPS, Purdue Disability Resource Center, Purdue Writing Lab, LGBTQ, and with cultural center directors like Black, Latino, Native American, Asian American, etc. Purdue Writing Lab expressed enthusiasm about engaging with PGSG if we have any idea on events that can engage them.

#### RedZone Tailgate

Coming up on September 14, 2024 in collaboration with CAPS, CARE, PSC and Corec. The goal is to promote alcohol education and sexual consent among Purdue students. We have four volunteers so far, including Ali and Sindu.

## **University Administration**

In collaboration with the community team and team chair, Sindu, I reached out to Dr. David Rollock and Jeff Stefancic on the possibility of speaking on the morning of November 4, 2024 during our mental health week opening ceremony. Exact date of MHAW to be confirmed with community team chair, Sindu. On September 5, 2024, I spoke to a long-time academic at Purdue, and now the associate dean of the Polytechnic, on his view on improving equity at Purdue since he is passionate about DEI. The inputs I got was that we need strategies to also make Purdue Online students feel belonged at Purdue, even an online session where they could introduce to others could help. We discussed the fact that online students did not pay the students' activity fee of \$20, but we should still engage them to be inclusive and not exclude them since they can feel isolated. I guess we need legislation here to the university senate, so if anyone is up to joining me on this, you are welcome to. He stated that we also need more aggressive strategies to engage folks from Purdue Indianapolis as they are essentially part of us, perhaps setting up online groups to make them feel included. Other DEI strategies are also to engage more matured students and students with families to make them feel belonged to the graduate community as they often feel isolated. He suggested we get a list of Purdue Indianapolis students, and engage more students in it. We also spoke about broadening the effort by CARE to get graduate students informed by initiatives from CARE, and he suggested initiatives like getting specific organizations, and specific dean involved as well to broaden impact. Also, disability needs to be part of the equation when we talk about DEI initiatives and he suggested we reach out to disability resource centers and such to make the disabled graduate students feel belonged at Purdue. Other efforts include not just engaging the cultural centers but also individuals that do not belong to any of these cultural groups.

#### **Graduate Student Organizations**

Since a lot of senators are also part of a graduate student organization, I hope this information could be helpful. Besides the graduate student organization grant by PGSG, there is this other grant from the Office of Diversity, Inclusion and Belonging. Applications due by September 13, 2024. However, it does require you to have collaborations with other graduate student organizations. If any GSO is interested we can potentially collaborate. The One Community Grant provides up to \$2500 for student-driven programs which promote inclusion and provide Purdue students with opportunities to engage with those from other cultures and experiences. On another note, question to the grant committee I guess, is there any possibility to raise the \$1,500 awarded to graduate student organizations?

#### **Shuttle Service Coordinator**

I'll be the shuttle service coordinator this year, and will coordinate with Somosmita to ensure that I'm effective in this role.



#### **Indiana Lifeline Law**

Together with Victor, I met with Rebecca from PSC to discuss the Indiana Lifeline Law not protecting underage victims. Victor suggested that our Legislative Affair officer, Alex, might be the right person to engage with, and I suggested they also engage folks in the Equity, Diversity and Inclusion space in the university senate as well.

#### Diversity, Equity and Inclusion Graduate Research Symposium (Poster Presentation)

# Report from Action Council Prep Meeting on Student Housing and Wellbeing

On August 20, 2024, I met with Beth McCuskey, Haley Oliver and Kevin Boes in the Provost Office. It was noted that graduate students do not typically utilize the local rate for on-campus housing, as many do not reside on campus. Graduate students often reference housing options such as the River Market and Launch Apartments when considering off-campus. The average housing cost for existing graduate students is approximately \$1,000 per month. This figure reflects the rates for typical off-campus housing options frequented by graduate students. There is a recognized need for housing that accommodates both individual graduate students and those with families. The availability and affordability of such housing remain a concern. Admissions processes and requirements for graduate students differ significantly from those for undergraduate students. These differences may influence housing needs and availability for graduate students. A significant amount of new housing is currently under construction. There is an ongoing discussion about whether this new housing will adequately address the current housing challenges faced by graduate students.

#### **New Diversity Member Recruitment**

We recruited around 16 new members this year, but many of our events are at odd times, so we do face issues with unavailability.
