 - 1. Lyft program that started this week issued 100 vouchers each worth \$20, all were claimed within the first six minutes. ~6 people have used the vouchers so far.
 - 2. Equitable parking resolution:
 - a) URPC (committee of the University Senate) says that discounting A permits for grad students would be unfair to staff who earn less than grad students.
 - b) They cannot recommend the current proposal, but they are supportive of grad students being eligible for A permits at non-discounted rates.
 - c) We need to determine exactly who should be eligible for what and at what time. The author will work on this.
 - d) Airport parking lot to Martin Jischke route did not work out so well.
 - 3. Move-in package resolution:
 - a) Purdue cannot pay us beforehand for services not provided.
 - b) Purdue can provide a loan of that money, then the first paycheck would pay off that loan.
 - c) University Senate requires modifications to this resolution that may be introduced today as emergency legislation.
 - 4. Question from Civil Engineering:
 - a) President: 8 grad students used it. I do not know if it would look different this year.
 - b) President: We can work with PRO to get a survey out.
 - 5. Question from ESE: Do you know about Indiana SB 235 which would target DEI at Purdue, possibly affecting cultural centers among other aspects?
 - a) President: I only heard about it this afternoon from a professor at Purdue Univ. Northwestern
 - b) President: Professor mentioned changing from DEI to NEI
 - President: I am not familiar with the legislation but I will get back to you through the Senate Chair or through officer reports.
 - d) President: I will not be able to hear about this through any Purdue meetings except the President's Advisory Council, I cannot report back.
